REVIEW OF MINUTES

COMMITTEE REPORTS

HIGHWAY- Superintendent Roger Chirico reported that the past storm caused a lot of damage to area roads. He stated that most of the roads are now passable. He also reported that the County Executive declared a state of emergency, which will hopefully result in FEMA funds to offset the cost (approximately \$915,000.00) associated with the recent storm. FEMA funds may be available to individual homeowners whose property was damaged. He credited his crew for the long hours and dedication they displayed.

PLANNING BOARD – Councilman Brower reported on the items addressed at the April 19th Planning Board Meeting. Councilman Shea interjected that the North Highlands Fire Department wants to meet with the developer to discuss some of the concerns they have with the proposed project.

RECREATION – Councilwoman Budney announced the upcoming events offered through the Recreation Department.

CAC – Councilman Shea stated that since the Town Board Meeting was pushed up last month, he has already reported on the activities of the CAC for April. The next meeting will be held on May 8th.

RECYCLING – Councilwoman Budney reported that the Town Wide Cleanup went well, and thanked everyone for his or her assistance in the coordination of this year's cleanup. She also announced that the Hazardous Waste Cleanup would be held May 19th from 9 a.m. – 1 p.m. at the Putnam County Health Department, 1 Geneva Road, Brewster.

BUILDING & LAND ACQUISITION – Councilman Shea announced that he had met with seven architects and the town is in receipt of seven proposals for the repairs to the town hall and the renovation of the Dahlia House.

ZONING – Councilman Brower stated that the last meeting of the ZBA was postponed. The next meeting will be Monday, May 14, 2007.

3. Natural Resources and Open Space Sub-committee of the Comprehensive Plan to address the Town Board.

Andy Chmar, Chairman of the Sub-Committee for Natural Resources and Open Space, stated that the committee is submitting a draft plan. This plan identifies ground and surface water, biodiversity, community character and outdoor recreation. The work of this committee has taken those four areas and come up with recommendations detailed in this draft plan. The goal of the committee was to present the town board with a plan that isn't something that is going to sit on a

shelf and be forgotten. The plan is condensed and focuses on actions that the town can undertake, whether it's residents or the town board or advisory committees, etc. Mr. Chmar then reviewed the visual chart. One item is to designate the Conservation Advisory Council as a Conservation Board. New York State Law allows that. It gives the CAC greater standing in the public review process of those aspects of development plans, wetland applications and individual house plans. He noted that it would not be a permitting authority, but a slightly higher standing in those processes.

Mr. Chmar then referenced the town's newsletter, which addresses the Community Preservation Fund, a fund designed for available funding to procure properties that the town deems appropriate or needed to be conserved.

Mr. Chmar then addressed the establishment of an Environmental Review Officer and lastly, to enact certain changes to the zoning land use laws that would further protect our natural resources. Mr. Chmar continued to review the visual chart, which addressed scenic buffering, etc.

For the record, members of this Sub-committee are Andy Chmar, Rich Anderson, Eric Lind, Fred Koontz, Marlo Kovacs and Jerry Rubino.

Councilman Shea expressed his gratitude to everyone who work on this plan and stated that it shows a level of commitment by the volunteers. Councilman Shea added that this plan is going to work in a sinuous way. In combination with other documents, this will be yet another tool valuable to the various boards.

The following items were addressed differently than they appeared on the agenda.

Town Clerk Merando asked that Items #4 and #5 be addressed upon the arrival of the Supervisor, who had been detained.

6. Resolution rejecting the bid for the complete boiler replacement at the Town Hall and authorize the Town Clerk to re-advertise for bidders.

Councilman Shea stated that the town is in receipt of one bid for the boiler replacement and it is the consensus of the Town Board to re-bid. There are many qualified local installers in the Town.

8. Allison Repetto to address the Town Board regarding Old Albany Post Road.

Mr. Repetto addressed the Town Board with regard to drainage problems on Old Albany Post Road. He also submitted photos showing the devastation from the past storm. Mr. Repetto applauded the Town's response to the storm. The area affected is the southern part of Old Albany Post Road, down by the monument, by Continental Village.

This subject generated a lengthy discussion whereby Mr. Repetto calculated water flow from the town roads with just an inch of rainfall. Mr. Repetto noted that in a three-mile section of this road, there are currently 20 drains that just drain into private areas. Not only does this water go onto private properties, but it also flows into sensitive areas carrying silt, road debris, oils and garbage. He noted that he has resided on Old Albany Post Road for 17 years and this overflow comes across his driveway and washes out sections of the driveway. Since the Repetto's have paved their driveway, it no longer cost a couple of hundred dollars to repair -- now it's thousands of dollars. Mr. Repetto asked what could be done to relieve this ongoing problem.

Councilman Brower interjected that this problem is not isolated to just this section of town. This is a situation that is occurring throughout the Town. He explained that as people start building on steep slopes, the water has to go somewhere. He further stated that this would be a continuing issue for the next few years, until the Town works this out. It is a serious and expensive issue that must be addressed. He noted that the Town is preparing to pass a local law that will address Stormwater runoff.

Conversation then turned to drainage and the proper size pipes needed to carry the overflow during a heavy rainstorm. Highway Superintendent Chirico tried to explain the different scenarios throughout the town and the problems that face the Highway Department in maintaining them with regard to Stormwater. Many residents from area roads submitted photos and explained what they experienced during this storm.

Following a lengthy discussion, Councilman Shea and Highway Superintendent Chirico will conduct a site visit in the interest of getting something done. This matter cannot be resolved in this forum, therefore, a site visit is warranted. The Town Board will also hold a workshop to address this matter.

10. Resolution authorizing Roger Chirico, Highway Superintendent to place 5 ton weight limit signs on Indian Brook Road from Route 9 – Route 9D, due to damage from the recent storm.

Town Clerk Merando read a letter dated May 1, 2007, from the Highway Superintendent requesting that weight limit signs be installed on Indian Brook Road.

Roger Chirico reported that there is a situation under the bridge approximately 2 miles in from Route 9D. He went on to say that there is a gabion wall that is about 225 feet long, which was installed about 15 years ago. This wall is now pushed out and traffic needs to be diverted to one side of the road. Mr. Chirico explained that if FEMA doesn't assist the town he would be forced to close the road. This is not the only area affected. A residence located at the other end of the road has experienced the same situation. A road closure is inevitable and the 5-ton signage is only temporary.

Robert Hutchinson of 30 Cross Timbers Road in Garrison addressed the Town Board requesting that a 5-ton weight limit sign be placed on Old West Point Road East from St. Anthony's Way to Old Albany Post Road due to damage from the storm.

Mr. Hutchinson also asked if there was anything that could be done on a regular basis to indicate a warning sign when the road is saturated to stop construction trucks from using it. Again, the Town Board would be conducting a workshop to further discuss this.

RESOLUTION #131-07

The following Resolution was presented by Councilwoman Budney, seconded by Councilman Brower and unanimously carried;

RESOLVED, that the Town Board hereby authorizes Highway Superintendent, Roger Chirico to place 5-ton weight limit signs on Indian Brook road from Route 9 - Route 9D, and Old West Point Road East from St. Anthony's Way to Old Albany Post Road, due to damage from the recent storm.

Councilman Shea turned the meeting over to Supervisor Mazzuca.

4. Schedule a Public Hearing on a proposed Local Law entitled filming in the Town of Philipstown.

Town Attorney Doyle explained that this would be a brand new law, which would require filming permits for filming, as defined in the law. This is an assemblage of several local laws from other municipalities that Town Clerk Merando obtained. This law was compiled by using the best provisions and the best approach, and the Town Board is the permitting authority. Town Attorney Doyle explained that this proposed law exempts news, still photography, filming for personal use of the family, etc. He also noted that there are time restrictions written into the law, which can be waived by the Town Board.

It was also noted that the fee schedule, as written in the law, would be established by resolution, thereby allowing the fees to be changed without having to amend the local law. This also holds true with the application for filming.

RESOLUTION #132-07

The following Resolution was presented by Councilman Brower, seconded by Councilman Hosmer and unanimously carried;

RESOLVED, that the Town Board hereby schedules a Public Hearing for a proposed Local Law to add Chapter 89, entitled Filming, to the Code of the Town of Philipstown, on May 16, 2007, at 7:00 p.m. at the Town Hall, 238 Main Street, Cold Spring, New York.

The Town Board then discussed scheduling a workshop with residents of Old Albany Post Road and Old West Point Road at the Continental Village Clubhouse. The workshop will be held on May 23, 2007, at 7:30 p.m. at the Clubhouse.

5. Award bid for the painting of the exterior of the Town Hall.

Supervisor Mazzuca reported that this is part of the grant application that we submitted. However, due to the required archeological study, the Town has not yet received confirmation of approval of the grant.

Councilman Shea and Supervisor Mazzuca agree that work on the Town Hall should take place before the Fall. Supervisor Mazzuca suggested that there is a possibility that the Town would have to borrow the money to complete much-needed repairs.

RESOLUTION #133-07

The following Resolution was presented by Councilman Shea, seconded by Councilman Hosmer and unanimously carried;

RESOLVED, that the Town Board of the Town of Philipstown hereby tables awarding the bid for the painting of the exterior of the Town Hall.

9. Kara Bickham to address the Town Board.

Kara Bickham stated for the record that she has no affiliation with the Julia L. Butterfield Library. Therefore, when voting on November 7th of 2006, she had adequate information to vote for the proposition. She noted that the information used to make her decision was, as in the past, read the newspaper. She referenced the dates that the referendum was discussed in the Putnam County News & Recorder. She strongly advocated that her vote should stand, just as the other people who bothered to vote for or against should stand. She then turned her discussion to the Town Board's decision to challenge the vote. Many accusations were put forth by Ms. Bickham in connection with this decision by the Town Board.

Louisa Perkins read a statement submitted by Karen Doyle as follows:

Statement to the Philipstown Town Council regarding the Butterfield vote, dated May 3, 2007. Members of the Town Council, my name is Karen Doyle, I am a Philipstown resident residing in the Village of Cold Spring. Thank you for allowing this statement to be read tonight, as I am unable to attend in person. Like others who have spoken here tonight, I knew well in advanced of Election Day last year about proposition 414. I recall reading about it in the PCNR in articles and letters to the editor. It was my understanding that the Town is determined that the public notice of proposition 414 was inadequate and that based on this determination, the Town has decided that the results of that election are null and void. The Town has decided this, despite what the voters have said with their votes. How can the Town Council make these determinations without taking this up with the Board of Elections? How can the Town Council overturn the outcome of an election? Does the Town have the power to do this? I don't think so. I too would like to hear the Town's explanations for its actions. I look forward to hearing the Town Council's response to this and all the statements and questions presented to it tonight on this issue. Thank you, Karen L. Doyle, Cold Spring, New York.

Elise LaRocco expressed her concerns with regard to the Butterfield vote and the Town Board's stand on this matter. She then read a letter she had written to the Town Board as follows:

"I think perhaps this is due to a misunderstanding of your constituents. I am sure when you first entered politics that spending money for a small library was low on everyone's priority. In fact, if this referendum were held in 1994 when you first became Supervisor I'm sure it would have been soundly defeated."

"However, Philipstown has changed since then. Today many residents value and rely on the Butterfield Library. Since 2000, the use of the library has increased tremendously with items circulated increasing from 8,020 to 38,000 in 2006. Library cardholders have increased from 2,583 to 4,052 with attendance for programs increasing from 2,882 to 7,795."

"So it may not be that residents were bamboozled but they were outvoted by newer residents who moved here after 1994 – residents whom you and the rest of the board need to get to know and learn what our desires and needs are for Philipstown as we love this town as much as any longtime resident. That's why we chose to come here."

"I am confident you and the board will cease your legal action and honor the referendum. By approving the referendum many of us "bamboozlers" would be happy to vote to re-elect you, as well as Al Hosmer and David Brower in November."

Steve Sterling stated that he sees it as something got voted on, yet wasn't budgeted for. He feels that no one wants to admit that something didn't get financially planned for and is being swept under the carpet. Based on what he is seeing and hearing, that there is any contesting of it, there doesn't seem to be any issue with that. However, there are some financial issues. He stands by the vote and feels that this has gone too far. He hopes that what ever needs to be done on a budgetary standpoint is addressed and that the vote is respected.

Supervisor Mazzuca responded saying he would like to clarify some things about the budget. In fact, \$125,000 was budgeted, even though the referendum was for \$276,000. The reason why the \$125,000 was originally put into the budget, we were told by the president of the library board that the money would not be needed until 2008. Although it is now being said that the Town Board misunderstood. The Town budgeted \$125,000, because we were told that the library understood the impact, so they would not want the money in 2007. He noted that this was discussed openly at several meetings, that it would not be 2007, but rather 2008. It was even discussed and noted at the budget hearings, that it would be 2008. He emphasized that no one called to say that the Town Board was wrong, that it has to be \$276,000.

Supervisor Mazzuca noted for the record, that the only executive session held at the Town Hall, was at the request of the Library. When the meeting was set up, it was the intention of the Town Board to have an open session. The Library stated that they would not meet with the Town Board unless it was in executive session with the attorney's present.

Supervisor Mazzuca explained that there is a question as to the time frame for contesting the election results of a proposition, unlike the time frame for elected candidates.

When a comment was made stating that the Town Board has a cavalier approach to this, Supervisor Mazzuca responded saying that it was a very difficult thing for the Town Board to deal with. The Town Board represents 10,000 people in this Town, not the 1,000 people who voted for/against this. Sometimes, you have to step up and do things that are not appreciated by the people when you think your acting for the good of the entire town. Supervisor Mazzuca noted that there is a technical aspect to this, it wasn't noticed properly in the newspaper. One of the comments from the Town to the library was that the library's argument wasn't with the Town but the Board of Elections.

The conversation continued addressing many questions with regard to the vote, the budget, legal notices, disbursement of the \$125,000, etc.

Joselle Cunane, resident from Continental Village, interjected that she is here this evening by herself, and would have gotten everyone in his or her car to attend this evenings meeting. She stated that she had spoken at last months

meeting with other residents that were not aware of the proposition, not by signs, not by e-mails, not by public notices. No one received any information in the lower half of Garrison. She pointed out that the residents of Continental Village utilize the Desmond Fish Library. She commented that Butterfield Library does offer a lot to the children.

Ms. Cunane asked what the money is earmarked for, and she was told it was to extend the children's hour. She reminded everyone that this matter is before the courts now and we will respect the decision of the judge. She also explained that she had presented the Town with petitions, signed by residents who believe that the proposition was a one-time appropriation. Another concern Ms. Cunane has is that the library can use this money any way they see fit.

Following a comment from Katherine Gotheth regarding procedures, Councilman Shea responded by saying "have proper procedures been followed?" The question being, was it noticed right -- was Election Law procedure followed -- technically, no, it was not.

Supervisor Mazzuca commented by saying that it is the issue of the technicality, but there are also other issues. He noted that no one wants to be in this position. If there was no error in the courts eyes, then so be it. However, Supervisor Mazzuca stated that he represents 10,000 people in the Town, the Town Board is obligated to respond to all the residents. Perhaps the actions of the Town Board have put the library in the position of having to go to court. He reminded the audience that the Town didn't take the library to court. He explained the various attempts made to open up communications between the Town and the library to no avail.

Discussion continued at length between the Town Board and members of the audience with regard to the Article 78.

Councilwoman Budney made a motion, seconded by Councilman Hosmer and unanimously carried that the CV Park District Vouchers in the amount of \$3,539.96 are hereby approved as presented in Abstract 4A and 5.

Councilman Hosmer made a motion, seconded by Councilman Shea and unanimously carried that the CV Water District Vouchers in the amount of \$6,931.52 are hereby approved as presented in Abstract 5.

There being no further business to discuss, Councilman Shea made a motion, seconded by Councilwoman Budney and unanimously carried that the Monthly Town Board Meeting is adjourned at 11:05 p.m.
